

Conditions for entry of students of the Faculty of Architecture of the CTU in Prague into the building of the Faculty Thákurova 9, Prague



The conditions are governed by the Rector's Order No. 7 to reduce the risk of coronavirus infection as amended by Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4 and Amendment No. 5.

1. **Students preparing bachelor's or diploma projects** for the purpose of **individual consultations** of these projects and **students who are registered for the state examination** in order to pass this examination are **allowed to enter the building**.
2. For the entire period that students will be in the building, **they are obliged to use respiratory protective equipment (face masks)**, persons who are not equipped with such protective equipment will not be allowed into the building. If students do not have their own face mask, they can request it at the reception desk.
3. Upon entering the building, students **shall present a valid student card and their identity will be verified** in the list of students preparing their bachelor or diploma project, or in the list of students enrolled for the state examination.
4. Subsequently, students **write down their name into a guest book** and the **filled "Affirmation on the absence of symptoms of viral infectious diseases and quarantine measures"** put into the mailbox. The Affirmation is attached to the Rector's Order No. 7 and also an annex to this document. The printed declaration is available at the reception desk.
5. Furthermore, the student takes **the shortest possible way** to the appropriate, predetermined room, for a **consultation of the final project or for a state exam. Access to the studio / consultation room is provided by the consultants. The secretariat shall provide access to the room where the state examination will take place.**
6. **Dates and place of consultations are announced by the supervisors and consultants** of the final works in person or through their secretariats. Students will receive **an invitation to the state examination, including the exact time** of the examination, to the **e-mail address given in KOS**.
7. **Individual consultations and state exams can only take place** in the presence of a **maximum of 5 people. Spacing** between people must be **at least 2 meters**. Upon entering the room, all participants will perform hand disinfection (disinfectants are provided by the faculty, their placement in individual rooms is a responsibility of the department). **Consultants and chairmen of state examination commissions are responsible for compliance with the above conditions.**
8. After consulting or passing the state exam, students **will leave the building immediately**.
